Revised European Union herbal monograph - final

The HMPC adopted after systematic review, revision and public consultation the following monograph:

Revised EU herbal monograph on Fumariae herba

European Union herbal monographs' review

Upon recommendation from the Rapporteurs, the HMPC decided after systematic review according to the procedure¹ EMA/HMPC/124695/2011 Rev. 3, to start the revision procedure for the following monographs because new data were identified that could change the monograph's content:

- EU herbal monograph on Ginkgo folium
- EU herbal monograph on Matricariae flos

The revision of the monographs and supporting documents will be added to the HMPC work programme.

The HMPC decided further after systematic review that no revision is required for the following monographs because no new data were detected that could change the monograph's content:

- EU herbal monograph on Myrtilli fructus siccus
- EU herbal monograph on Myrtilli fructus recens
- EU herbal monograph on Ricini oleum
- · EU herbal monograph on Rubi idaei folium
- EU herbal monograph on Sisymbrii officinalis herba
